## A simple, free way to submit

Use **Claim Submission** on the UnitedHealthcare Provider Portal to enter claims electronically using the same information as the CMS-1500 paper form. This tool is ideal for small practices that don't work with an electronic data interchange (EDI) clearinghouse.

### With Claim Submission, you can:

- ✓ Submit professional claims, including National Drug Code (NDC) claims, for all UnitedHealthcare plan members
- ✓ Easily see which fields are required; the highlighted fields will update based on the information you enter
- ✓ View on-screen messages that allow you to correct certain errors before you hit submit
- ✓ Reduce paper, eliminate postage and mail time

### Quickly see whether your claim was accepted or rejected

It's easy to check the status of your claim submissions. To access the Claim Submission tool, go to [UHCprovider.com](https://uhcprovider.com) > Sign In > Claims & Payments > Submit a Claim. Please be sure to check for rejected claims and resubmit them within your timely filing limit.
